All these assets have been developed by Chardon over the past four decades.

It operated over 50 hotels around the UK under a variety of global brands, including: Hilton, Holiday Inn, Holiday Inn Express and Hotel Indigo. It was sold to the world's largest independent hotel management company, Interstate Hotels and Resorts.

Throughout his years in the industry, Maurice has been the proud recipient of a plethora of awards, including a Lifetime Excellence Trophy at the CIS Excellence Awards 2015 and Entrepreneur of the Year from a number of august bodies. He is currently visiting Professor at the Scottish Hotel School and holds an Honorary Doctorate from the University of Strathclyde.
